The Company is managed by a Manager. The person initially appointed as Manager is **Dale Conway**.

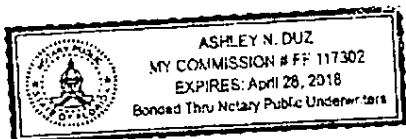




