ARTICLE III - Management

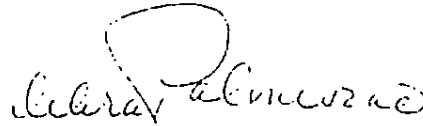
The Company shall be managed by its manager and is therefore a manager-managed Company. The name of the initial manager of the Company is Daniel Coosemans.
