# ARTICLES OF ORGANIZATION OF THE DRIFTLESS GOAT COMPANY, LLC

The undersigned, pursuant to the provisions of Chapter 605 of the Florida Statutes, for the purpose of forming a Limited Liability Company under the laws of the State of Florida, does set forth the following:

#### ARTICLE I - NAME .

The name of the Company is THE DRIFTLESS GOAT COMPANY, LLC.

#### **ARTICLE II - DURATION**

The duration of the Company is perpetual.

### ARTICLE III - ADDRESS AND PLACE OF BUSINESS
