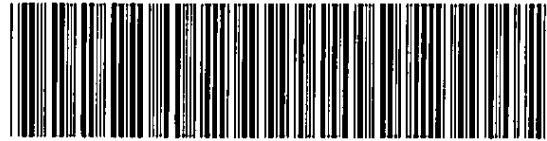

SECOND: The Florida Department of State Document Number of the Company is L17000260724.

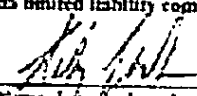
