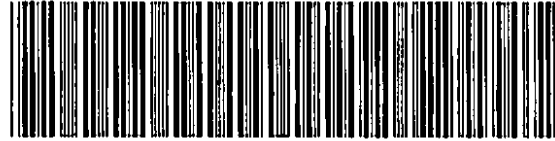

**ARTICLES OF ORGANIZATION

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, F.S. Chapter 605, hereby make, acknowledge, and file the following Articles of Organization to go into effect on January 1, 2018.

ARTICLE I - NAME

The name of the limited liability company shall be WATTSOUND SECURITY, LLC ("Company").


ARTICLE X - MANAGEMENT
