**ARTICLES OF ORGANIZATION****OF****MICHAEL CALUDA, M.D., PLLC**

Pursuant to Section 605.0201 of the Florida Revised Limited Liability Company Act, Florida Statutes, as amended from time to time (the "Act"), the following are adopted as the Articles of Organization of the professional limited liability company organized hereby:

**ARTICLE I  
NAME**

The name of the professional limited liability company is Michael Caluda, M.D., PLLC (the "Company").

**ARTICLE II  
EFFECTIVE DATE AND DURATION**

The effective date upon which this Company shall come into existence shall be the date these Articles of Organization are filed. 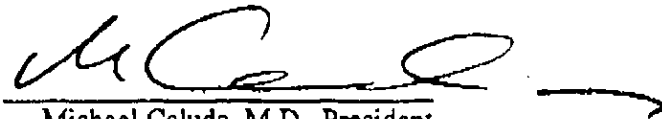
