ARTICLES OF ORGANIZATION FOR FLORIDA LIMITED LIABILITY COMPANY

- Conduct its business, locate offices, and exercise the powers granted by Florida Statutes Chapter 605 within or without the State of Florida.
- Scleet managers and appoint officers, directors, employees, and agents of the Company, define their duties, fix their compensation, and lend them money and credit.
