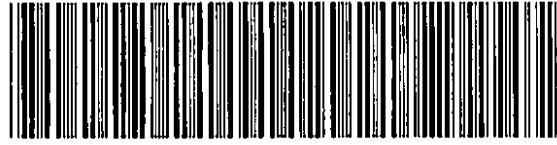

These Articles of Conversion and attached Articles of Organization are submitted to convert **CFG XV, Inc.**, a Florida corporation (the "Corporation"), into **CFG XV, LLC**, a Florida limited liability company (the "LLC"), in accordance with Section 605.1045 of the Florida Revised Limited Liability Company Act (the "Act"). 1. The Corporation was formed under the Florida Business Corporation Act by the filing of its Articles of Incorporation with the Florida Department of State on December 8, 2015 under Document Number P15000097549.
2. The name of the Corporation immediately prior to the filing of these Articles of Conversion is CFG XV, Inc.

ARTICLE II - PRINCIPAL OFFICE




