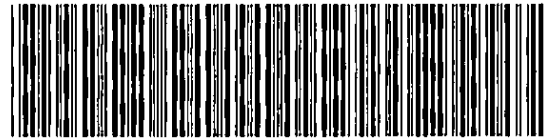

These Articles of Conversion and attached Articles of Organization are submitted to convert **CNL Capital Markets Corp.**, a Florida corporation (the "Corporation"), into **CNL Capital Markets, LLC**, a Florida limited liability company (the "LLC"), in accordance with Section 605.1045 of the Florida Revised Limited Liability Company Act (the "Act").

1. The Corporation was formed under the Florida Business Corporation Act by the filing of its Articles of Incorporation with the Florida Department of State on December 28, 1999 under Document Number P99000111329.
2. The name of the Corporation immediately prior to the filing of these Articles of Conversion is CNL Capital Markets Corp.
3. The name of the LLC as set forth in the attached Articles of Organization filed in accordance with Section 605.1045 of the Act is CNL Capital Markets, LLC.
4. The plan of conversion was approved by the Corporation and the LLC as required by Section 607.1112 and Sections 605.1041 – 605.1046 of the Act.
5. The converted entity has agreed to pay to the members of any limited liability company with appraisal rights the amount to which such members are entitled under Sections 605.1006 and 605.1061-605.1072 of the Act.
6. The effective date of the conversion shall be December 31, 2017.


