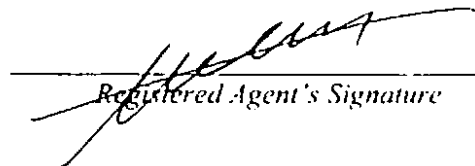
ARTICLE I
