**ARTICLES OF ORGANIZATION
OF
HRMFL, LLC**

The undersigned, desiring to form a limited liability company under and pursuant to the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, does hereby adopt the following Articles of Organization.

**ARTICLE I
NAME**

The name of the Limited Liability Company shall be: HRMFL, LLC.

**ARTICLE II
ADDRESS**

**ARTICLE III
PURPOSE**

ARTICLE VI ADOPTION OF OPERATING AGREEMENT

ARTICLE VII REGISTERED AGENT AND OFFICE

ARTICLE VIII CONTINUATION OF BUSINESS

Unless dissolved in accordance with the Company's Operating Agreement, the remaining members shall continue the business of the Company, which shall not be dissolved, upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member.
