ARTICLES OF ORGANIZATION

OF

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statute, hereby makes, acknowledges. and files the following Articles of Organization.

ARTICLE I - NAME
