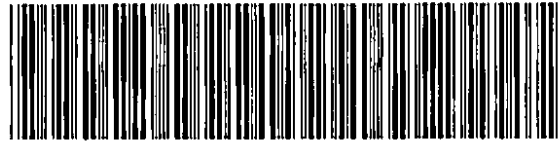

**ARTICLES OF ORGANIZATION  
OF  
SD FRUITVILLE COMMONS, LLC,  
a Florida Limited Liability Company**

The undersigned, being the duly authorized representative of the initial members of a limited liability company to be organized under the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, adopts and submits the following Articles of Organization for such limited liability company:

**ARTICLE I  
NAME**

The name of the limited liability company is **SD FRUITVILLE COMMONS, LLC**, a Florida limited liability company (the "Company").

**ARTICLE II  
PRINCIPAL PLACE OF BUSINESS**

The mailing address and street address of the principal office of the Company shall be **2639 Professional Circle, Suite 101, Naples, Florida 34119**.

**ARTICLE III

Newly admitted members shall have all of the rights and privileges as set forth in the Company's Operating Agreement and Regulations.

DURATION**

ADOPTION OF OPERATING AGREEMENT AND REGULATIONS**



Until such time as a successor or substitute is elected, appointed or designated in accordance with the Operating Agreement and Regulations, the Manager of the Company shall be as follows:


