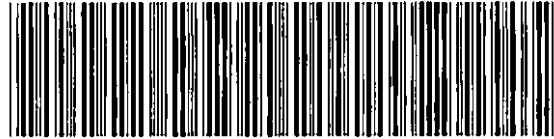


ARTICLE V. MANAGEMENT


