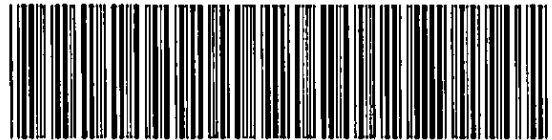

**FOURTH:** This entity exists before the merger and is a domestic filing entity.


