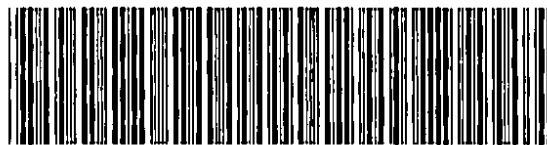

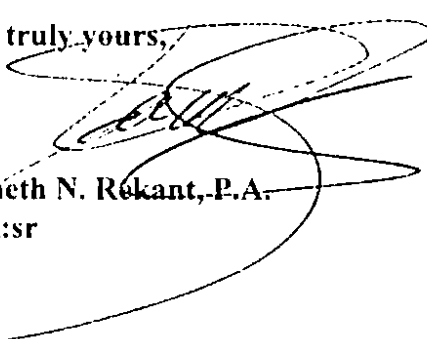

ARTICLES OF ORGANIZATION OF
L & G MIAMI, LLC

ARTICLE I - NAME

The name of the limited liability company ("Company") is L & G MIAMI, LLC.

ARTICLE II - ADDRESS

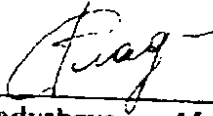
ARTICLE VIII - AMENDMENT OF ARTICLES

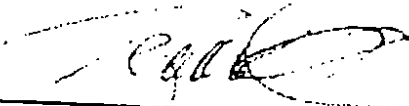
