**AMENDMENT TO THE ARTICLES
OF ORGANIZATION OF
ROB'S PLACE, LLC**

The undersigned, for the purpose of Amending the Articles of Organization of ROB'S PLACE, LLC (the "Company") under §605.0202, of the Florida Revised Limited Liability Company Act, F.S. Chapter 605, hereby makes, acknowledges, and files this Amendment to the Articles of Organization of ROB'S PLACE, LLC. The original Articles of Organization for the Company were filed with the Florida Department of State on January 8, 2018. The Amendment is set forth as follows:

1. The name of this Company is ROB'S PLACE, LLC.
2. The Articles of Organization, as amended, of ROB'S PLACE, LLC, have been amended by deleting Article V in its entirety and by substituting in lieu thereof the following Article:

Article V - NAME

The Company shall be managed by its Member in accordance with the terms of the Operating Agreement of the Company, if any, and applicable law. The Member may appoint persons to serve as officers of the Company who may have those duties and obligations as directed by the Company from time to time in accordance with the terms of the Operating Agreement, if any, and applicable law. The following is the initial Member of the Company:

Robert and Michelle Parman, Tenants by the Entirety 100%

3. The referred to Amendment was adopted by the Company on January 25, 2018, by its sole Member.
4. Upon the filing of these Articles of Amendment by the Department of State, the above referred to Amendment shall become effective and the Articles of Organization of ROB'S PLACE, LLC shall be deemed to be amended accordingly.
