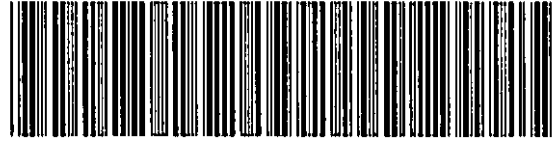

This Limited Liability Company shall have perpetual existence.


ARTICLE VI. PURPOSE


