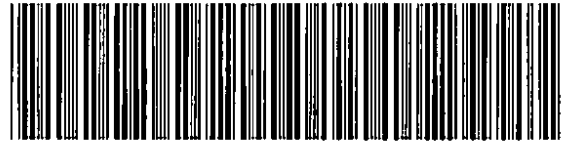

**ARTICLE I.



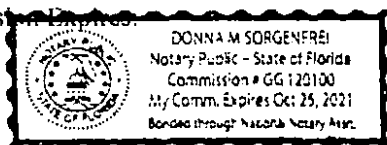


