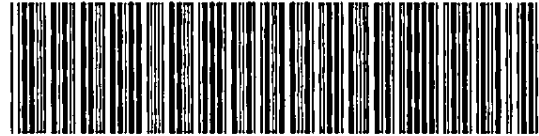

ARTICLE II - ADDRESS


The mailing address and street address of the principal office of the Company is 209 Courthouse Square, Inverness, Florida 34450.


Certificate of Designation of Registered Agent and Registered Office
