**Article One  
Introduction and Preliminary Statements**

The undersigned Organizer desires to form a limited liability company under the Laws of the State of Florida by delivering these Articles of Organization in duplicate to the Department of State of the State of Florida, in accordance with Revised Florida Limited Liability Company Act, Ch. 605, Florida Statutes (the *Act*).

**Article Two  
Name**

The name of the limited liability company is 838 Mendoza, LLC, a Florida limited liability company (*Company*).

**Article Three  
Duration**

The Company will perpetually exist from the filing date of these Articles of Organization with the Department of State of the State of Florida, unless dissolved according to law.

**Article Four


