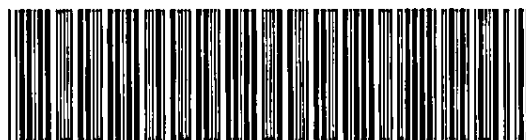

16. **Further Assurances.** The parties shall, at any time and from time to time after the date hereof upon the request of the other party or the Company, or their successors or assigns, execute, acknowledge and deliver such further instruments of conveyance, assignment, transfer, powers of attorney, consents and assurances and shall take such other action as may reasonably requested in order to more effectively consummate the transactions contemplated herein. This provision shall survive the closing or termination of this Agreement.

17. **Attorneys' Fees:** In the event of any legal action between Assignor and Assignee regarding this Agreement, the prevailing party shall be entitled to payment by the non-prevailing party of its reasonable attorneys' fees, paralegal fees and litigation expenses as determined in the course of the proceeding, including bankruptcy proceedings and the right to such reasonable attorneys' fees, paralegal fees, and costs shall be deemed to have accrued from the commencement of such action and shall be enforceable whether or not such action is prosecuted to judgment.




