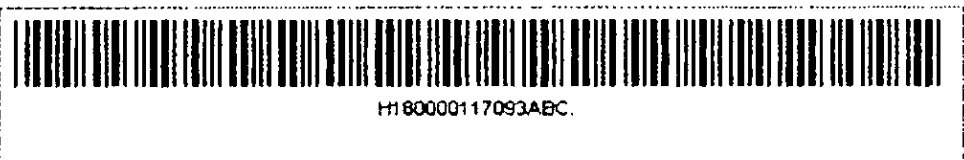

The name of the limited liability company is Chill Four LLC.


ARTICLE II. ADDRESS


