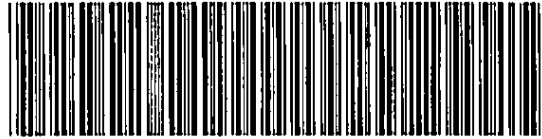



The jurisdiction of the "Other Business Entity" has not changed since the filing of the Articles of Incorporation in Florida on October 19, 1994.






