

ARTICLES OF ORGANIZATION OF HARBAUGH PROPERTIES, LLC

ARTICLE 1 Name and Principal Place of Business

The name of this limited liability company is HARBAUGH PROPERTIES, LLC; the physical address of its principal office is 5309 Cottonwood Tree Circle, Valrico, Florida 33596, and its mailing address is 5309 Cottonwood Tree Circle, Valrico, Florida 33596.

ARTICLE II Purposes

Additional contributions will be made as required and as determined by unanimous consent of the members and will be made in such proportionate amounts as to maintain the capital accounts in the same proportion as arose from the original contribution set forth above.
