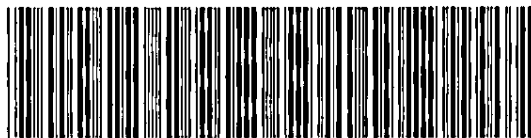

ARTICLES OF CONVERSION
