**ARTICLES OF ORGANIZATION
OF

The undersigned, Phillip Stutts, a natural person competent to contract and an authorized representative of Phillip Stutts & Company, LLC, hereby presents these Articles of Organization as the Articles of Organization of Phillip Stutts & Company, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I – NAME
