

THIS AGREEMENT AND PLAN OF MERGER (this "<u>Agreement</u>") relates to the merger of WCI COMMUNITIES RIVINGTON. LLC, a Delaware limited liability company, having a mailing address of 700 N.W. 107<sup>th</sup> Avenue, Suite 400, Miami, Florida 33172 (the "<u>Non-surviving Entity</u>"), with and into MERGERCO, LLC, a Florida limited liability company (the "<u>Surviving Entity</u>"), having a mailing address of 700 N.W. 107<sup>th</sup> Avenue, Suite 400, Miami, Florida 33172.

WHEREAS, the Non-surviving Entity and the Surviving Entity wish to enter into a merger agreement pursuant to which the Non-surviving Entity will merge with and into the Surviving Entity and the Surviving Entity will be the surviving business entity.
