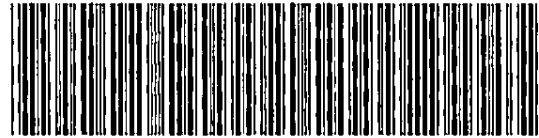



**ARTICLES OF ORGANIZATION
IMO CASA, LLC**

These Articles of Organization ("Articles") are adopted, effective this 11th day of October, 2017, pursuant to Chapter 605, Florida Statutes, the Florida Revised Limited Liability Company Act (the "Act"). The undersigned sets forth the following:

**ARTICLE I
NAME**

The name of the Limited Liability Company is IMO CASA, LLC (the "LLC").

**ARTICLE II
ADDRESS**

The mailing address and principal office of the LLC is: 855 E. Plant Street, Suite 1500, Winter Garden, FL 34787.

**ARTICLE III
MEMBERSHIP AND FORM OF MANAGEMENT**

The LLC shall be Member-Managed within the meaning of Section 605.0407, Florida Statutes, and have a single member consisting of Innovation Montessori Ocoee, Inc., a Florida nonprofit corporation (the "Member"). The LLC shall not admit any additional members at any time. The LLC shall be governed by the Act, these Articles, and the Operating Agreement, of even date herewith.

**ARTICLE IV
PURPOSE**

The purpose for which this LLC is organized is to further the charitable and educational purposes of its Member, specifically, without limitation, the provision by the Member and the Member's Governing Board of a voluntary prekindergarten education program within the meaning of Sections 1002.51 through 1002.79, Florida Statutes, and as recognized for purposes of charter school enrollment preferences pursuant to Section 1002.33(10)(d), Florida Statutes. The LLC will also qualify for derivative tax exempt status as a disregarded entity within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or a related section of a successor statute (the "Code"), by virtue of its relationship with the Member. The LLC will also qualify through its exempt status relationship derived from its Member as a charitable organization for purposes of receiving deductible gifts and grants within the meaning of Section 170(b)(1)(A) of the Code, and to engage in any lawful act or activity for which limited liability companies may be organized under Florida law and are not otherwise prohibited by these Articles of Organization or the LLC's Operating Agreement or the Code. However, nothing herein shall be construed as allowing any activities which would jeopardize the Member's tax exempt status or otherwise be inconsistent with the Member's classification as an organization described in Section 501(c)(3) of the code and its regulations as they now exist or may hereafter

be amended, or as a corporation, contributions to which are deductible under Section 170(c)(2) of the Code.

ARTICLE V REGISTERED AGENT

The name and address of the registered agent of the Limited Liability Company is Patrice M. Cherico, 855 E. Plant St., Suite 1500, Winter Garden, FL 34787.

ARTICLE VI AMENDMENTS OR RESTATEMENTS



No oral representations by the Member shall be deemed or construed to constitute any portion of, or otherwise affect the interpretation of, these Articles of Organization.
