

## ARTICLES OF ORGANIZATION FOR FLORIDA PROFESSIONAL LIMITED LIABILITY COMPANY

The undersigned does hereby present these Articles of Organization for the formation of a professional limited liability company under the provisions of Chapter 21, Florida Statutes.

#### ARTICLE I - NAME

The name of the Professional Limited Liability Company is GCPI Holdings, PLLC.

#### ARTICLE II - ADDRESS
