**ARTICLES OF ORGANIZATION  
OF  
MALSALGATOR, LLC**

These Articles of Organization are submitted for the purpose of forming a limited liability company pursuant to the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, as the same may from time to time be amended, superseded or replaced (the "Act").

**ARTICLE I - NAME**

The name of this limited liability company (the "Company") is MALSALGator, LLC.

**ARTICLE II - ADDRESS**

The initial address of the principal office and the initial mailing address of the Company is 1529 3<sup>rd</sup> Street South, Jacksonville Beach, FL 32250.

**ARTICLE III - INITIAL REGISTERED OFFICE AND AGENT**
