# ARTICLES OF ORGANIZATION OF ALIEN SHRIMP ENTERTAINMENT, LLC

& FILED 8 JAN 22 PM 1: 31

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Revised Limited Liability Company Act (Florida Statutes Chapter 605).

#### ARTICLE I

<u>Name:</u> The name of this limited liability company is Alien Shrimp Entertainment, LLC (the "Company").

### **ARTICLE II**

Mailing Address and Street Address: The Company's mailing address and street address of the principal office is 120 Jefferson Avenue, Miami Beach, Florida 33139.

#### **ARTICLE III**

Registered Agent and Registered Office: The name and the Florida street address of the registered agent are as follows: Corporate Creations Network Inc., 11380 Prosperity Farms Road #221E, Palm Beach Gardens, FL 33410.

# **ARTICLE IV**

Management of the Company: The Company is to be managed by its members and is, therefore, a member-managed limited liability company.

#### ARTICLE V.

<u>Termination of Membership:</u> If a member of the Company dies, retires, resigns, is expelled, is dissolved, experiences bankruptcy, or upon the occurrence of any other event which terminates the continued membership of a member in the Company, the remaining members may, by unanimous written agreement, continue the business of the Company.

#### **ARTICLE VI**

<u>Regulations</u>: The members shall have the power to adopt, alter, amend, or repeal regulations of the Company containing provisions for the regulation and management of the affairs of the Company.

#### ARTICLE VII

<u>Date of Existence of the Company</u>: The existence of the Company shall commence on the date of filing the Articles of Organization by the Florida Department of State.

# **ARTICLE VIII**

<u>Duration:</u> The Company shall exist from the date of filing these Articles with the Department of State until the occurrence of any of the events specified in Florida Statutes Section 605.0701, unless continued by the unanimous consent of all of the remaining members.
