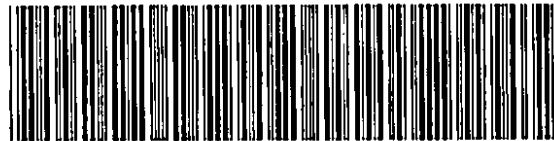



ARTICLES OF ORGANIZATION OF  
KROME GROVE FOUR, LLC

The undersigned, desiring to form a limited liability company under and pursuant to §605.0201, Florida Statutes, does hereby certify as follows:

ARTICLE I  
NAME

The name of said limited liability company shall be:

ARTICLE II  
TERM

Krome Grove Four, LLC shall exist in perpetuity.

ARTICLE III


