# ARTICLES OF ORGANIZATION OF MONTUL AT THE PARK, LLC

The undersigned, for the purpose of forning a limited liability company under the Florida Revised Limited Liability Company Act, pursuant to Chapter 605 of the Florida Statutes, hereby makes, acknowledges and files the following Articles of Organization (the "Articles").

# ARTICLE I NAME
