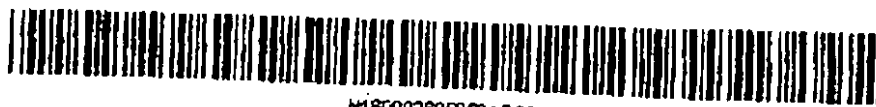

ARTICLES OF AMENDMENT
TO
ARTICLES OF ORGANIZATION
OF

Pursuant to Section 605.0202, Florida Statutes, Baymeadows Park LLC (the "Company"), hereby delivers to the Secretary of State for filing these Articles of Amendment:

FIRST: The name of the Company is Baymeadows Park LLC.

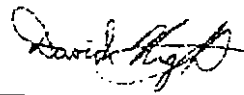
SECOND: The Articles of Organization were filed on January 25, 2018.

THIRD: The Articles of Organization shall be amended to delete Article IV in its entirety and replace it with the following:

"ARTICLE IV - MANAGEMENT AND AUTHORITY:

The Company shall be a manager-managed company. The initial managers of the Company shall be David Kight, Joel Chamberlain and Ken Atlee, each of whose address is P.O. Box 54688, Jacksonville, Florida 32245. Pursuant to Section 605.04074, Florida Statutes, no member of the Company shall be an agent of the Company solely by virtue of being a member, and no member shall have authority to incur debt or contractual liability on behalf of the Company solely by virtue of being a member."
