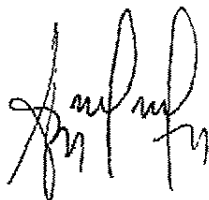

As we discussed over the phone a few minutes ago, On January 15th. 2018 I started the filing of a new Limited Liability Company under the name of "Abstractum LLC". (Corporate Filing – 800307889318). However, on January 18th 2018, I received a communication from the Division of Corporations notifying me that the filing could not be completed because there is another corporation with a name that is not distinguishable from the one I am filing. (The document number of the name conflict is P06000127832-ABSTRACTUM CORP.)

The purpose of this letter is to inform you that I am the principal in both entities, and on January 22nd. 2018, I completed the online filing for the dissolution of Abstractum Corp. I also confirm that I have no intention to revoke this dissolution and as such, I release the name, therefore I kindly request that you please complete the filing of the new company, Abstractum LLC. The reason for this new filing is the need of an LLC instead of a C Corp as it is more adequate for my present requirements.
