Pursuant to the provisions of Chapter 605 of the Florida Statutes, the undersigned hereby declares the following provisions as the Articles of Organization of BULK NANO COMPOSITES LLC, a Florida limited liability company (the "Company").

ARTICLE 1: NAME AND MAILING ADDRESS

No member of the Company shall be an agent of the Company solely by virtue of being a member.


ARTICLE 7: OPERATING AGREEMENT


