ARTICLES OF ORGANIZATION OF DAVIDSON HOLDINGS #2, LLC

The undersigned, for the purpose of forming a Limited Liability Company under the Florida Limited Liability Company Act, Chapter 605, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I NAME

The name of the Limited Liability Company shall be DAVIDSON HOLDINGS #2, LLC ("Company"). The principal place of business of the Company in Florida shall be 7699 Faul Buchman Highway, Plant City, Florida 33565, and the mailing address shall be 7699 Paul Buchman Highway, Plant City, Florida 33565.

ARTICLE II DURATION
