**ARTICLES OF AMENDMENT TO
ARTICLES OF ORGANIZATION OF
SCHISLER, LLC**

The undersigned, Kyle M. Schisler, a natural person competent to contract and an authorized representative of Schisler, LLC, hereby presents these Articles of Amendment to the Articles of Organization of Schisler, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

These Articles of Amendment to the Articles of Organization of Schisler, LLC, a Florida limited liability company (the "Company"), are executed by the undersigned authorized representative of the Company, for the purposes set forth herein.

1. The name of the limited liability company is Schisler, LLC.
2. The Articles of Organization were filed on January 29, 2018 and assigned document number L18000025187.
3. The Company has approved and adopted the following amendment to the Articles of Organization, and Article III is hereby amended and restated in its entirety to read as follows:

"ARTICLE III - PURPOSE AND POWERS

The Company is organized for the sole purpose of operating franchised Chick-fil-A Restaurant business(es) under a Franchise Agreement with Chick-fil-A, Inc. and to exercise all other powers and rights necessary to, or reasonably connected with, the operation of the franchised Chick-fil-A Restaurant business(es)."
