Pursuant to Section 605.1025 of the Florida Revised Limited Liability Company Act (the "Act"), 422 GOLDEN BEACH LLC, a Florida limited liability company, formed on May 24, 2017 with document number L17000115543 ("422 GOLDEN BEACH", and also the "Merging Entity") and 483 CENTER ISLAND LLC, a Florida limited liability company, formed on January 30, 2018 with file number L18000026698 (the "Surviving Entity"), adopt the following Articles of Merger merging the Merging Entity with and into the Surviving Entity (the "Merger"):

FOURTH: The Surviving Entity exists before the merger and is a domestic filing entity.

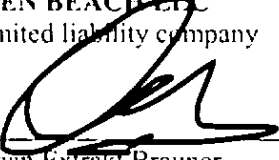

SIXTH: The merger shall become effective upon the filing of these articles with the Secretary of State of Florida.

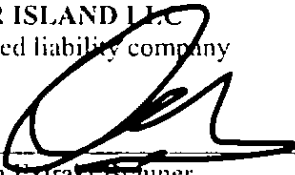
SEVENTH: This Certificate may be executed in one or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.
