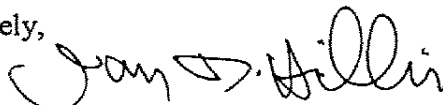
I am writing in reference to rejected filing number W17000098262, as submitted to the Secretary of State on behalf of "U.S. Tax Accounting, LLC."
