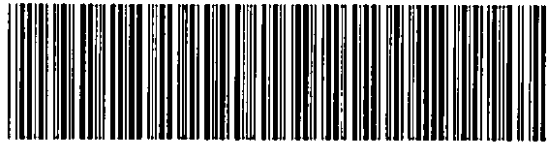

The undersigned, being the sole member of Wrobel Belize, LLC, adopts the following Amended and Restated Articles of Organization pursuant to the authority and provisions of Section 605.0202 of the Florida Revised Limited Liability Company Act:

FIRST: The name of the limited liability company filing these Amended and Restated Articles of Organization is WROBEL BELIZE, LLC (the "Company")

The Original Articles of Organization for this Limited Liability Company were filed on January 31st, 2018 and assigned Florida document number L18000027613.
