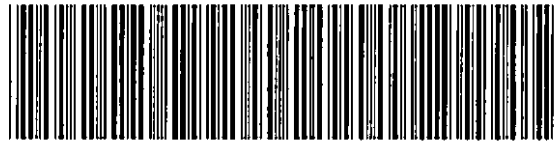


**ARTICLE II


