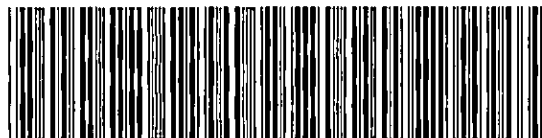

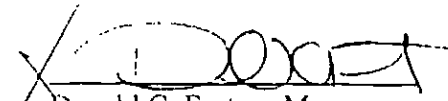
### **ARTICLE IV: MANAGEMENT OF THE COMPANY**

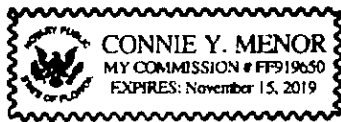
