**AMENDED AND RESTATED ARTICLES OF ORGANIZATION
OF
PLATECH ENTERPRISES, LLC**

Platech Enterprises, LLC, a Florida Limited Liability Company (the "Company"), whose Articles of Organization were filed on February 5, 2018, hereby certifies as follows:

The Articles of Organization of the Organization are hereby amended and restated by as follows:

ARTICLE I

Name, Mailing Address and Purpose of Organization

The name of this limited liability company is PlaTech Enterprises, LLC (the "Company"). The Company's principal address and mailing address is 3277 Cloverplace Drive, Palm Harbor, FL 34684. 


