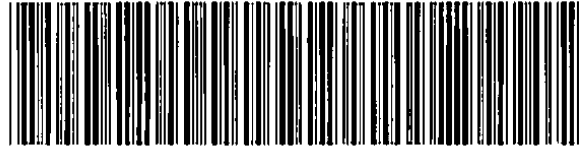





**SIXTH:** The merger shall be effective as of the date the Articles of Merger are filed with the Florida Department of State.




