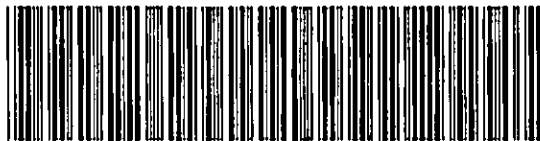

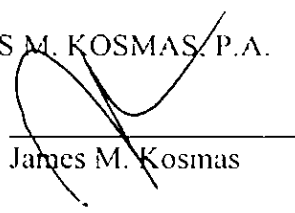

ARTICLES OF ORGANIZATION

ARTICLE I – NAME

The name of this limited liability company is ESP 3, LLC, a Florida limited liability company.

ARTICLE II – ADDRESS

The mailing and street address of the principal office of the Company is 1601 Tionia Road, New Smyrna Beach, Florida 32168. The Company reserves the right, power and authority to establish offices at such other places as may be designated by the Company.

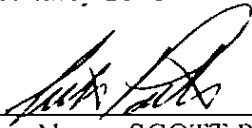

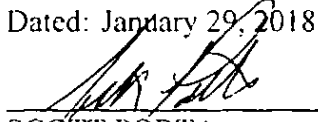
CERTIFICATE OF DESIGNATION OF REGISTERED AGENT/REGISTERED OFFICE
