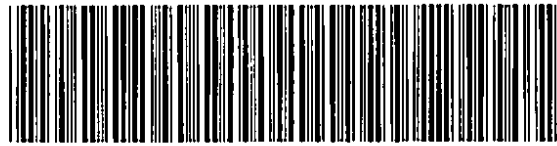


Enclosed for resubmission is an Articles of Amendment for a name change to the above referenced LLC.




