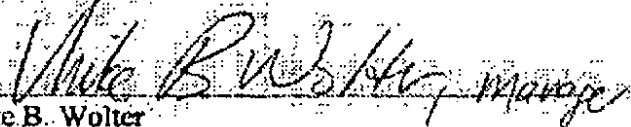

The undersigned executed these Articles of Organization on the 12 day of February, 2018.

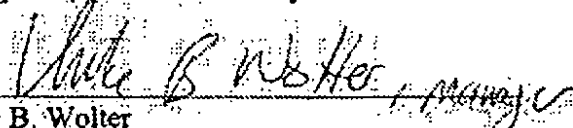
