**ARTICLES OF ORGANIZATION
OF

The undersigned, HARRY B. STACKHOUSE, a natural person competent to contract and an authorized representative of a member of TOTAL LAND CREATIONS, LLC, hereby presents these Articles of Organization as the Articles of Organization of TOTAL LAND CREATIONS, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is TOTAL LAND CREATIONS, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

The initial principal address of the Company is 125 E. Intendencia Street, Fourth Floor, Pensacola, FL 32502, and the initial mailing address of the Company is P.O. Box 730, Laurel Hill, FL 32567. The Company's mailing address and principal office may hereafter be at such other place or places as its members from time to time may determine.

ARTICLE III - PURPOSE AND POWERS

The Company is organized for any legal and lawful purpose for which a limited liability company may be organized and shall have all powers and rights which a limited liability company may exercise pursuant to Chapter 605, *Florida Statutes*.

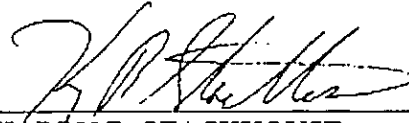
